- You may also utilize RTR to request demurrage charges in order to generate an invoice number allowing for offline payment through ACH or wire transfer. Please note that ACH, and wire transactions are dependent on your financial institutions processing time - generally 1-2 business days - could result in payment clearance delay and additional demurrage fees.

For other US locations:
