



Update 3 - Negotiations Between the USMX and ILA

Dear Valued HMM Customer,

As of this morning, there has been no further progress on the Master Contract negotiations between the USMX and the ILA which expires on September 30, 2024.

The USMX remains committed in sitting down with the ILA to continue the bargaining process.

Since we are 10 days out from the expiration date of the Master Contract, many terminals are either offering extended gates or advising of their plan on receiving cargoes up to the September 30, 2024 deadline.

We encourage our customers to utilize offered extended gates and check the various terminals' websites for additional information on restricted deliveries, etc.
