



Amendment No. 6 to

NVOCC Service Arrangement UWLD24037

THIS Amendment No.6 dated the 1st day of November 2024 (this "Amendment") is by and between THE FASHION ACCESSORIES SHIPPERS ASSOCIATION, INC. d/b/a GEMINI SHIPPERS ASSOCIATION ("ASSOCIATION"), and UWL, Inc. ("UWL") (Shipper and UWL are each a "Party", and together the "Parties").

WHEREAS:-

- A. The Parties have entered an NVOCC Service Arrangement, UWLD24037 dated July 10, 2024 ("NSA")
- B. The Parties have agreed to amend the wording of the NSA on the terms set out in this Amendment.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:
