US Import Reefer Trade: Genset Surcharge Update (NYC)

Dear ZIM Customer,

As originally published on August 23, 2018 and effective **October 12, 2018**, ZIM will be implementing a \$200 USD genset surcharge per container for the use of a genset on merchant haulage moves for refrigerated container loads destined to the US from all origins.

The surcharge will be invoiced separately to the account of the consignee unless prepaid by shipper, and payment will need to be settled prior to container release at destination.
