US Import Reefer Trade: Genset Surcharge Update (NYC)

Dear ZIM Customer,

As originally published in the ZIM Tariff, we have implemented a \$275 USD genset surcharge per container for the use of a genset on merchant haulage moves for refrigerated container loads destined to the US from all origins.

The surcharge will be invoiced separately to the account of the consignee unless prepaid by shipper, and payment will need to be settled prior to container release at destination.

Should a genset not be required for a shipment, please notify our Customer Service team at 1-866-744-7046, and the charge will not be applied. Should a genset not be used for a shipment, ZIM will not be liable for any damage caused to the cargo for lack of the genset.
